

## **Operations Intern**

## **Description and Main Purpose of Role**

The role is designed to allow the intern to acquire the skills and experience for collecting accurate survey data using both conventional and innovative technology. The intern will assist in carrying out required tasks on survey projects, including equipment maintenance, operations, and data acquisition in accordance with safe work procedures.

#### **Main Duties and Responsibilities**

- Assist project planning and preparation.
- Participate in project mobilisation and demobilisation activities.
- Assist procurement and logistics activities.
- Assist in communicating with authorities on the ground in project locations.
- Assist in the servicing and maintenance of USVs.
- Assist on launch and recovery of USV's from quayside/deck.
- Participate in project and maritime operation Risk Assessments.
- Acquire knowledge of basic field concepts, survey practices, and survey procedures.
- Develop knowledge and understanding of survey software and hardware.
- Develop the ability to understand and assist in calibrations.
- Assist in data acquisition including online logging and records.
- Demonstrate an understanding of system calibrations and the effect of calibration on data quality.
- Attend all daily Job Safety Analysis / Toolbox Talks.
- Play an active role in the QHSE culture of the business and ensure compliance with relevant regulations.
- Adhere to the Company's procedures and policies.
- Perform any other delegated duties or tasks as instructed by your Line Manager.
